The present invention finds application in situations where the sensitive information is transmitted from one database over a communication link that may not be secure or over a communication channel that may be owned or controlled by third parties. In some circumstances, a database administrator (DBA) may be required to communicate a set of data, including sensitive data such as personally identifiable information (leg., update an account balance on a payment card). The DBA typically collects the required data and then communicates the data, including the sensitive data, to the application using a computer program. In this case, the sensitive data may be transmitted over a communication channel that may not between a desktop computer and a server, and communication between an Internet tronser and a web site. Examples of third party communication links include sending a hard copy of a credit card number to a bank, and transmitting information over a personal communication service. The transmission of sensitive information, such as PII, over a communication channel that may not be secure or over a communication link that may be owned or controlled by third parties presents an issue of privacy. The transmission of PII to a third party, such as an application in a secure environment (e.g., a PC running an application program that is not accessible by third parties) or, in some cases, a third party in a non-secure environment (e.g., a consumer using a mobile phone that is connected over a third party communication link), raises issues of privacy. These issues may be addressed by paying attention to the following: (1) the security of the data (e.g., whether all of the data contained within the data secure of
